The meeting opened at 7:30PM. The November minutes were read and approved. The November 2010 Treasurer's report was read and accepted. Balance brought forward was \$12,349.07, deposits were \$75.00 and disbursements for the month totaled \$2,208.87. Ending balance was \$10,215.20. Guests in attendance were Bill Starr, William Roberts, and Todd Miller, all attending their first meeting.

Old

- The bridge over the creek is now in place and construction complete. Bryan Miller secured and placed the 48' steel flatbed trailer on concrete supports in recent weeks and it looks fantastic. We may now drive the four-wheeler and the mowing tractor across the bridge for easy mowing access. The approach areas have been graveled. The ramp sides need seed and straw. The need for rails on the bridge edges for safety reasons was discussed and will be followed up on at the next meeting. Total cost of the project to date is estimated at \$1450.00.
- Please note that for safety and liability reasons, personal vehicles are NOT to be driven across the bridge.

New

- The street light in front of the clubhouse is out. Ronny Brown agreed to report this to the utility company.
- Norm Gozler reminded the club that a F-Class rifle match will be held on December 4th with registration starting at 8:00 AM and shooting at 9:00 AM.
- The .22 Indoor League will start on January 6th at 6:00 PM at the clubhouse.
- Ronny reported that the yearly all-around match would be held on the second and third Saturdays in January for rifle and then on the second and third Saturdays in February for shotgun and pistol.
- Steve Roe gave a report on the .22 Tactical Steel Challenge match held in October and November. The match has been well attended with 14 shooters in October, 23 in November and 25 to 30 shooters anticipated in December. The match has been also well attended by junior shooters with up to a fourth of the shooters under 15 years old. Trophies are now presented to the top three finishing junior shooters and a cash purse is awarded to the top three overall shooters. For 2010, the December match will be held on the 11th starting at 9:00 AM. Details are on the club website. If you have a 22 rifle come on out and shoot!
- Due to the large decline in participation in the .22 (smallbore) IHMSA matches, a proposal was made to discontinue the matches for 2011 and re-evaluate in January, 2012. The proposal included the replacement of the 22 IHMSA match in 2011 with the 22 Tactical Steel Challenge rifle match. The proposal was voted and approved. Starting in March, 2011, the .22 TSC match will be held the 2nd Saturday each month from March-December.
- Shannon Lyndon proposed a "Vendor Day" at CVRPC with representatives and equipment present from several major firearms manufacturers and additional vendors including Remington, Smith & Wesson, and others. This event will be open only to CVRPC members. Targets, guns, and ammunition will be provided by the vendors. A Tentative date of May 7th, 2010 was proposed and approved by the club.
- A target order will be placed in the near future. Please see Ronny Brown or Tim Drum if you have a specific target you would like to order and have available at the club.

The meeting was adjourned at 8:07 PM.
