October 4, 2012

The meeting opened at 7:30PM. The September minutes were read and approved. The September 2012 Treasurer's report was read and accepted. Balance brought forward was \$47,808.63, deposits were \$837.00 and disbursements for the month totaled \$39,848.52. Ending balance was \$8,797.11. The treasurer further reported that there are 127 total members, 56 of which are seniors and 73 are "regular" members, leaving 52 openings. Guests this month are Donovan Douglas, Kenneth Parker and Philip Keaver, first meeting, Brian Franklin, 2nd meeting and Jim Bentley, 5th meeting. Tim Drum reminded prospective members that there will be a walk-around and range rule talk scheduled for 6PM on November 1st, just before the November meeting.

OB: The 2-gun challenge match took in \$150, with \$45 going into the club treasury. The next 2-gun match will be held on Saturday, December 8th. The new benches for the 300 yard firing line are not yet in place, and there is still more gravel to be spread in the muddy areas by the new cover. Ronnie announced that there are only two more land payments to be made, finishing the purchase in 2014. The next 22 rimfire steel match will be held on October 6th. at 10AM. Tim Drum announced that at the November 4th. shoot there will also be a Zombie shoot held with multiple reactive targets being used.

NB: Norm Goetzler reminded the members that there is an "F-Class" BR shoot held on the first Wednesday of the month, starting at 9AM, plus an October 27th. F-class prone 300 yard match. Saturday, October 13th. will be the last .22TSC match of the year. A question was asked about whether or not the club's phone line included any unnecessary charges for long distance capability. John Grimes will check on this. A question was also asked whether or not all the scheduled matches were on the club's web calendar. Ronnie will check and report.

The recent Executive Committee meeting minutes and recommendations for match procedures were read and discussed, with the following results:

The recommended supply and placement of 4 new shooting benches under the 300 yard line cover was unanimously approved.

- Recommendation 1 was approved unanimously.
- Recommendation 2 was approved with modification but with one dissenting vote.
- Recommendation 3 was approved unanimously.
- Recommendation 4 was approved unanimously.
- Recommendation 5 was approved unanimously.
- Recommendation 6 was approved unanimously with modification.
- Recommendation 7 was approved unanimously.
- Recommendation 8 was approved unanimously.
- Recommendation 9 was approved unanimously, with an addition to cover "side matches".

The new match rules will go into effect at the beginning of the calendar year 2013. John Grimes provided a "CVRPC Match Income and Expense Report" sheet to be used by each match director to track expenses.



The ERO noted that more Empty Chamber Indicators are needed at the various firing lines, and that magazines must be out of the gun when the ECI is in place. The ERO also reminded all members that no targets shall be placed so that bullets impact the side berms.

The meeting was adjourned at 8:54PM.
