**August 7, 2014**

The meeting was called to order at 7:30 PM by club president, Randy Clark. The July meeting minutes were read and approved. The July, 2014 Treasurer’s report was read and accepted. Balance brought forward was \$55,710.93, deposits were \$1,331.00 and disbursements for the month totaled \$902.99. Ending balance was \$56,138.94. Guests this month were Dale Mitchell 1<sup>st</sup> meeting, Michael Guffie and Lanny Huffman 2<sup>nd</sup> meeting, and James Norman 3<sup>rd</sup> meeting. **Old Business:**

- The steel plate racks at the pistol range has 10 new targets and the remaining 2 targets and additional poppers are expected within the next two weeks.
- The club reviewed the spaces available at the 300 yard line and decided to allow two additional benches to be constructed to bring the total amount of benches available to 8. This will keep 4 bays open for prone, positional, and other shooting. It was advised the two new benches be added on the right side of the firing line.
- The study of the CCW training class frequency was discussed and determined that the current number of classes being held has not interfered with normal range activity and usage.
- The trenching from the clubhouse to the front gate area has not yet been completed and will be addressed at a later date.
- Ronny Brown reported that the final land payment will be made in September, 2014.

**New Business:**

- The regularly scheduled Work Party days will continue next Thursday, August 14<sup>th</sup>. All those who are able are encouraged to attend.
