The meeting was called to order at 7:30 PM by club president, Randy Clark. The August meeting minutes were read and approved. The August, 2014 Treasurer’s report was read and accepted. Balance brought forward was \$56,138.94, deposits were \$540.00 and disbursements for the month totaled \$183.05. Ending balance was \$56,495.89. Guests this month were Teddy Smith, Bill Shamblin, and Peter Garvey - 1st meeting; Michael Guffie and Lanny Huffman 3rd meeting; and Mike Charles, 4th meeting. Old Business:

- Ronny Brown advised the club the final land payment was made on September 2nd and CVRPC is now debt-free.
- The trenching from the clubhouse to the front gate is scheduled to be performed on Thursday September 11th at the time of the monthly Work Party.
- The steel plate rack is awaiting further components to complete the repairs.
- The newly approved additional benches for the 300 yard line have yet to be constructed. Additional concrete forms for the benchtops will have to be made.

New Business:

- The regularly scheduled Work Party days will continue next Thursday, September 11th. All those who are able are encouraged to attend.
- Harold Wilson advised that there will be no further F-Class matches at CVRPC.
- Harold Wilson advised that beginning in 2015, CVRPC will hold monthly 300 yard benchrest matches. This will be a score only type format with a single Open category class. A match will consist of 45 rounds. A trial match of this format will be held on November 29th. The remaining regular benchrest matches will be held on the 4th Saturday of September, October, and November, 2014.
- Steve Roe advised the September .22 TSC match will be held on the 13th. Matches are scheduled for October and November.
- Ronny Brown advised the TGAC 3-gun match will be held on Saturday, September 6th at 10:00AM.
- George Northam advised the 2014 NC State High Power Championship match will be held at CVRPC on September 20-21st.
- It was brought to the club’s attention the wobble trap machine is broken and in need of repair. Discussion followed regarding the need for a protective structure for the wobble trap. The possibility of a cover/roof/structure will be investigated and reported back to the membership at the October meeting.
- Keith Harper requested the date of November 15th for a “Personal Protection in the Home” training class. The date was granted.
- Tim Drum advised that the .22 Speed Challenge matches will be held the 3rd Saturday in September and October. The October match will be a team type format.
- Prospective members are reminded to contact Executive Range Officer Tim Drum regarding a range “walkaround” prior to receiving their membership key.



- Keith Harper and Randy Clark advised the members present of several new NC CCW laws. Members are advised to research NCDOJ.gov for additional and specific information.
- Jeremy Abbott advised there are several sections of phone/power poles at the 100 yard line area available free if anyone is in need of these items.
