The meeting was called to order at 7:30 PM by club president, Sam Birchfield. The June meeting minutes were read and approved. The June, 2016 Treasurer’s report was read and accepted. Balance brought forward was \$36,672.29, deposits were \$4,871.00 and disbursements for the month totaled \$2,733.88. Ending balance was \$38,809.41. Old Business:

- We now have a working land line phone in the meeting room. The number is 828-256-8755.
- No bathroom remodel work has yet been performed. We have acquired a new toilet for the lady’s restroom but it has not been installed.
- An Executive Committee meeting will be held on Monday June 11th at 6:30 PM to discuss CCW carry during matches held at CVRPC.
- Gary Houser reported the refrigerator refreshments “Honor System” is working well. As such we will continue with this system for the summer months.
- Bob Metts reported the wobble trap has been repaired and is in working condition.
- The subject of the 100 yard line upper access road has not been fully discussed or investigated and will be tabled until the August meeting.

New Business

- A question was asked regarding the quality of the water at the clubhouse; specifically, if it is drinkable. The membership is advised the water is supplied by the City of Conover and any inquiries regarding the water quality should be addressed to the City of Conover.
- George Northam advised that he has installed a post at the 100 yard line for attachment of a chain to limit traffic during matches at the 200 or 300 yard lines.
- Tim Drum advised that 11 members still have not completed a Walk Around.
- John Grimes advised that 3 members have left the club; and 12 members has not yet paid their 2016-2017 dues.
- It has been reported that several of the new access keys are not working, or work with difficulty. Please see John Grimes regarding an exchange for any improperly working keys.
- Due to the heat experienced in the summer month meeting and training events at the CVRPC clubhouse meeting room, the subject of possibly installing a central air/heating unit (heat pump) was raised. Steve Roe and Bob Metts will discuss this with club member Barry Brittain and secure a quote and report back to the membership.
- A Work Party is scheduled for Thursday, July 14th at 4:00PM.
- Ronny Brown advised the tractor is not in running condition due to an issue with the fuel pump or possibly the injector pump. Ronny will diagnose the issue and replace the needed part.
- A fallen tree at the 100 yard line has been removed. Additional trees and brush may be in need of removal.
- Steve Roe advised the .22 TSC Match will be held on Saturday July 9th at 10:00 AM. Set up of the match will begin at 8:30 AM prior to the match.
